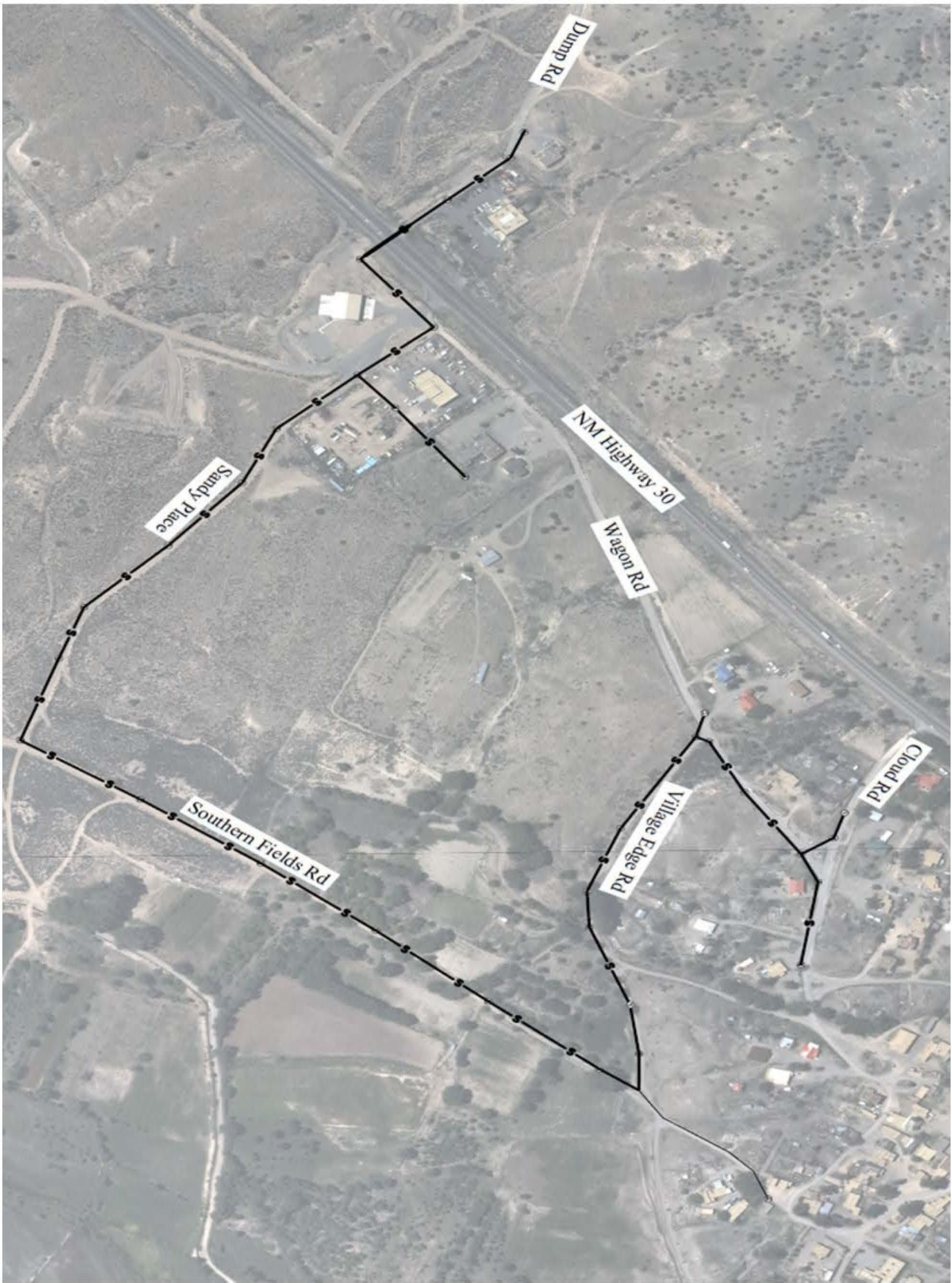
Re: **Notice of Construction Project, Village Sewer Improvements**

This notice is to inform you of an upcoming construction project that will focus on installing the sewer mains and a lift station in the Village area. See attached map. The objective is to install new sewer mains and a lift station to remove homes from septic tank systems. This project is a benefit to the Pueblo as it will replace failing infrastructure, improve operations and maintenance.

CF Padilla, LLC from Isleta Pueblo is the Contractor who will be working on the project along with Souder Miller and Associates. Traffic may be diverted to different locations during this time, please be mindful of construction workers and maintain your speed.

This work is expected to be completed in July 2024. The Santa Clara Tribal Administration appreciates your patience during the construction phase. 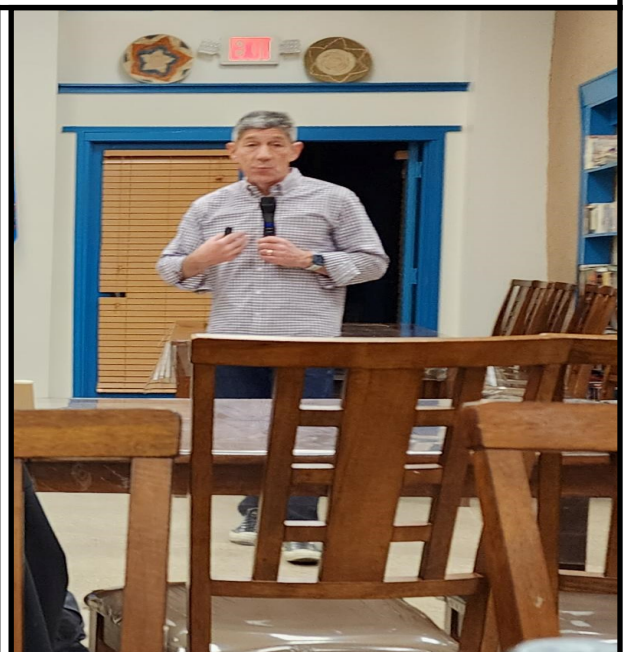
The **Small Business Start-up Day 3.0** was held at the Santa Clara Senior Center on January 18th. Santa Clara Library and the Inter-governmental Dept. coordinated with the UNM Rainforest Innovations and Truth Dancer Coaching to host the presentations on Intellectual Property, Copyright and Trademark.



Dr. David Irvin, traveled from NMSU to present on patents and trademark resources available from his office. Through the NMSU Library, Reference and Research Office, Dr. Irvin conducts research on brand and trademarks and provides awareness of strength and weakness of brands. Although the research is free, it does cost to register a trademark and it must be renewed after 5 years. A registered trademark is a legal proceeding.

Esquire Seth Gardenswartz from Blackgarden Law in Albuquerque shared awareness of their legal specialties including trademarks, contracts, payment systems, e-commerce, digital media and general business management. Attendees learned that Intellectual Property includes different types: Patent, Copyright and Trademark, which are registerable.

Intellectual Property , IP, Right is a complicated topic, especially with artificial intelligence on the horizon. There are many more questions on how to manage intellectual protections in the future. Look for updates on future Small Business Start up Sessions.

The Santa Clara Pueblo Office of Vital Statistics & Enrollment, would like to inform Enrolled Members and Non-Member Residents, that the OVSE will be scheduling appointments for those individuals who have been accepted as an enrolled member & a Non-Member Resident. If you have a lost, damaged, or expired Tribal and Non-Member Resident Identification card, update your ID card today.

Call our office to update your documents and schedule an appointment.

### Documents needed for Identification Card

- Official certified state-issued birth certificate.
- Current Address (addresses must be updated as changes occur and proof of residency, agreement physical address, must be provided). Current New Mexico Driver's License or Photo ID card.
- Current Contact Information (landline, cell phone, & email address).
- Adoption Documents of an enrolled member, from any tribal, state, or federal jurisdiction.
- Custody documents of a minor child, from any tribal, state, or federal jurisdiction.
- Name change document of an enrolled member from any tribal, state, or federal jurisdiction.
- Other pertinent information includes, but is not limited to, marriage license/certificate, informal marriage (common law) registrations, divorce decree, power of attorney statements, land records, church records, military records, High school Diplomas or GED Certificates, and/or other school or tribal records, documentation or COVID-19 vaccination card (all three vaccines)
- Have not had symptoms of COVID-19 in the last two weeks of scheduling your appointment.
- Family appointments are accepted as long as documentation is up to date

# Home Base Native Intensive Clinical Program

Lifesaving care for Native American Veterans, Service Members and their Families – all at no out-of-pocket cost.

Native Americans serve in the United States Armed Forces at higher rates than any other ethnic group. Yet, the unique needs of Native American Veterans, Service Members and their Families facing challenges with geography, infrastructure and access to specialty care make it exponentially more difficult for those impacted by the invisible wounds of war.

Our innovative **Native Intensive Clinical Program (ICP)** was built upon our flagship ICP through consultation with Native American Veterans, tribal leaders and healthcare administrators. The Native ICP provides long sought after healing and lifesaving care to Native American Veterans, Service Members and their Families at no out-of-pocket cost to them.

Our next cohort will be held from June 16-28, 2024, at our National Center of Excellence in Charlestown, MA. Additional offerings are currently in development. Please contact us for more details.

SAMHSA is seeking the best ideas from U.S. youth, aged 14-18, on a community strategy to educate their peers about fentanyl and fake pills — and prevent drug overdose deaths.

SAMHSA wants youth to pitch ideas that educate peers and their communities (among their friends, at school, or within an organization to which they belong) about fentanyl and fake pills with the goal of preventing overdose. Ideas could include innovative ways to reach youth on this topic, such as social media posts, vlogs, podcasts, video journals, etc. Youth can participate individually, or as part of a team.

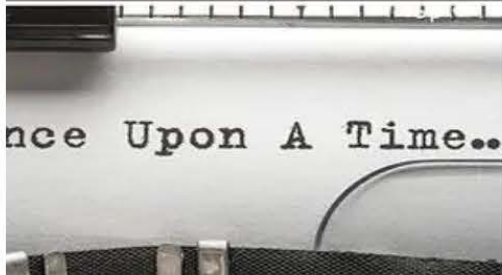
