RE: **Village Clean-up St. Anthony's Feast Day**

Village Clean-up for St. Anthony's Feast Day will be held on **June 11, 2024 at 5:30 p.m.** All male residents will assemble in front of the church at 5:30 p.m. to sign-in with the Sheriff.

It is mandated by the Tribal Council that **all male community residents between the age of 16 and 65 shall participate in all community work**: ditch cleaning, Pueblo clean-up, etc. Failure to participate will result in certain privileges that will not be afforded to you. (Hunting, Wood & Dirt Permit).

To be excused from these activities you must have a doctor's verification submitted to the Governor's Office that you are medically unable to participate or disabled.

RE: Flow of traffic in Village area Feast Day

This letter is to inform the Community of changes in the flow of traffic on June 13, 2024 Feast Day.

On this day the flow of traffic will turn into a one-way street on (1) Back Wall Road South to Cloud Road (2) Hillside Road Southeast to Back Wall then South on Cloud Road (3) Drum Road South onto Cloud Road then South exiting at State Road 30. This will take effect at midnight on June 12, 2023, as we get ready for vendors to set up at 5am of the 13<sup>th</sup>. Please be mindful of all signs and personnel that are posted in areas. Also, as a reminder the speed limit in the Village Area is 10 miles per hour (MPH) or otherwise posted. See map that is attached.

Entrance/ Exit at Drum Road off State Road 30 will be opened and Wild Rose Road will be closed for the day at the entrance/exit off State Road 30, this area will be used for over flow of vendors.

**Please remind family members, visitors and guests that there will be no cell phones allowed in Main Village, no picture taking or recording of any kind. All rules will be posted in different locations.**

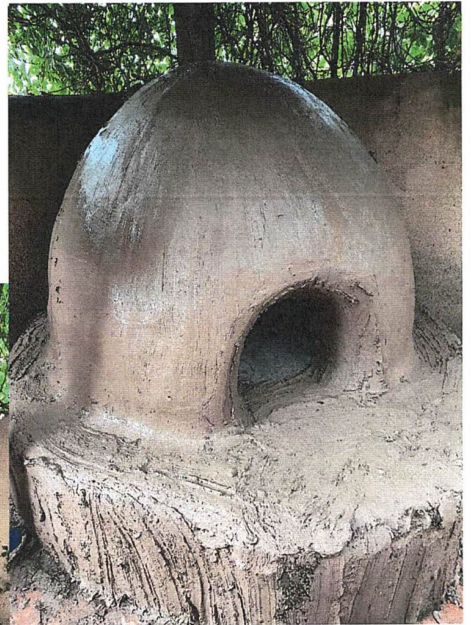
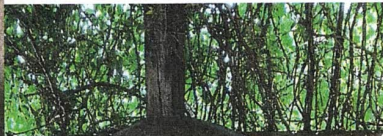
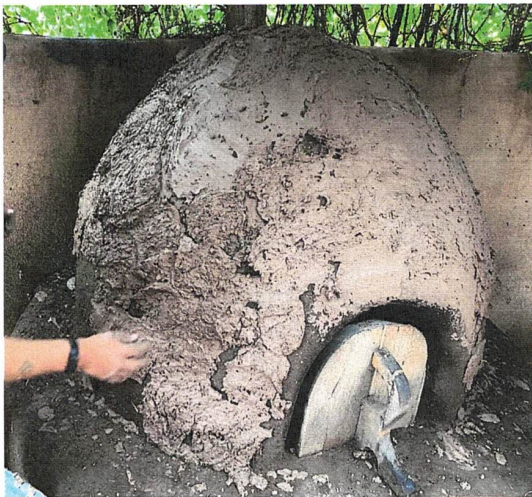






Bapibo Kha'Po Community Members,

I hope you are all doing well in 2024. We are excited to announce that the SCP Rights Protection Office has received funding from the New Mexico Youth Conservation Corps (YCC) for another year of projects. Our office has been collaborating with YCC since 2007 and has completed many years of restoration, maintenance, and preservation work for our ancestral home of Puye. This year, we plan to have another round of Re-plastering pan'te (hornos) for the community elders. We are reaching out to the Kha'po Community to inform you that if you have a pan'te that requires a new coat of plaster or minor repairs, please contact the SCP Rights Protection/THPO office. We have ten spots available for the 2024 project, which will be given on a first-come, first-served basis. Once we have received ten submissions, the Rights Protection staff will evaluate your pan'te before the 2024 YCC crews start. Depending on the type of work required, the Rights Protection staff will inform you if you have been placed on the list for re-plastering. We want to inform you that not all individuals who sign up for re-plastering will get their pan'te worked on due to the short time we have YCC crews. # **Santa Clara Pueblo**

## **Office of Emergency Management**

The Emergency Management office is comprised of two employees: James F. Baca, Emergency Management Director, Rayeandrea Gutierrez, Emergency Management Technician. Currently the department has two (2) openings for Administrative Assistants. The Emergency Management department was formed in 2011 after the Las Conchas Fire and subsequent floods in the Santa Clara Pueblo Canyon. The goal of the department is to maintain situational awareness, be proactive and to protect the life, safety and welfare for the Santa Clara Pueblo. The departments responsibilities include:

- Planning, Training, Response and Recovery from all man made and nature caused emergencies/events within the Pueblo Boundaries to include:
  - Fires
  - Floods
  - Traffic Crashes
  - Gas Leaks/Outages
  - Power Outages
  - Pandemics

The Office of Emergency Management is currently working on several projects. The first project involved the revision of the current All Hazards Mitigation Plan. This plan will help the Pueblo focus on mitigation specific projects for the next five (5) years. Most of the projects contained in the revision deal with work that needs to be completed post fire/flooding. The second project, once completed with the HMP, will be to work on a Threat and Hazard Identification Risk Assessment (THIRA). This assessment will help the Pueblo to identify the threats and hazards that pose the most danger. One completed, the THIRA will work hand in hand with the HMP and will help the Pueblo to make decision on its path forward with recovery. Finally, OEM is also working on revisions to the Emergency Operations Plan and the Pandemic Plans. Once these are completed the will also be incorporated into the documents the Pueblo will use for emergency response.

The Department's primary focus was on emergency response during the COVID-19 Pandemic; however, the department was still responsible for the Pueblo's response to any and all man-made/natural disasters in the Pueblo. There were a lot of lessons learned during the pandemic which will be added to the Emergency Operations Plan. Also, we continue to monitor the conditions in the canyon and throughout the Pueblo. We have assisted in the implementation of short- and long-term recovery projects in the Pueblo's watershed from the source, down to the confluence of the Rio Grande River.

The Special Projects and Safety of Dams office is under the direction of Daniel J. Tafoya. Our office includes several programs and a multitude of projects. Our staff includes Assistant Director Paul Torres, Budget Analyst Vida Baca, Field Supervisor Joey Gutierrez, Road Technicians Anthony Baca, Joshua Povijua, and David Ortiz.

#### **Heavy Equipment and Roads Programs**

The overall priority of these two programs are to maintain all tribal roadways. This includes, vegetation control, road grading, pavement patching, street sweeping and snow plowing. The staff are required to always be on call to ensure the roads are safe for drivers.

#### **Canyon and River Irrigation Systems**

Our office manages the operations of our irrigation systems. This season we have contracted Mr. Mitchel Calabaza as the Ditch Caretaker. Construction from the winter 2023 is not complete. Our goal is to pick up where we left off this winter.

#### **Safety of Dams Program**

The BIA provides annual funding for our flood Early Warning System. The system provides real time notifications to warn us of a potential flood or increased run-off problem. The system is monitored 24 hours a day and maintenance twice a year.

We want to wish the Santa Clara Pueblo and Community blessings and good health. We wish all of the 2024 Graduates, congratulations, and that they move into the future with great knowledge, skills, and insights that they gained through their education and to inspire them when faced with challenges and difficulties. As they move into the future they grow more knowledgeable and achieve more to assist their families and community.

The Rights Protection Office has been currently working on an array of projects, we have completed our Cultural Resource Management Plan (CRMP) for the Pueblo. A field visit to ancestral sites in Southwest Colorado, and Northwest New Mexico with the Kha'Po Community School. Our Ethnographic study with Cultural Committee Members on the Greater Chaco Region for the Chaco Heritage Tribal Association (CHTA). We will be starting up the 2024 Youth Conservation Corps (YCC) program with 18 youth doing projects on Trail Restoration on areas in the Santa Clara Canyon and at Puye, Wildlife inventory on identification of various wildlife on the reservation and Aquatic monitoring, and the Panteh Project (Horno) restoration. We have collaborated with various agencies and governments to assist the youth in trainings, teambuilding, instilling our core values of Santa Clara, respect, responsibility, resilience, compassion, community, integrity, language, and making it a good learning experience for the youth giving them the courage and awareness to move into the future with new skills. We will also collaborate with the Bandelier National Monument and the National Park Service Bandelier through a Multi-Year Funding Agreement (MYFA) to have 6 crew members working in the park boundary on masonry and trail projects, both project crews will be working for nine weeks.

We continue to work with all departments in the Tribal Administration and other Agencies in the realm of Cultural Resource, Preservation and Protection, along with our Water Rights negotiations in the Abbott Water Rights Case and Management on the entire



reservation of Santa Clara Pueblo. The Office of Rights Protection may be contacted at (505) 753-7326 ext. 6285.

## Santa Clara Pueblo Tax Administration

The Tax Administration Department is responsible for administering all tax matters for the Pueblo. The duties extend from the issuance of business licenses to the collection and reconciliation of the various taxes imposed on commercial entities doing business on or with the Pueblo.

Taxation on tribal lands is a contentious topic throughout the US because states have historically claimed the authority to tax all economic enterprises on tribal lands. Tribes have fought this assumption in the courts and in the legislative halls of state government. While the situation improves, there is still much ground to be gained. The biggest problem with states taxing tribal businesses and businesses operating on tribal lands is that the taxes collected, rather than being used by tribes for the betterment of their communities, go to the state and are rarely if ever seen again. Infrastructure, education, and social programs that could benefit from those dollars, don't see those dollars. When tribes impose taxes in addition to the state taxes, the goods and services involved become more expensive and less likely to be consumed.

Nationally, courts and legislatures are siding more with tribes on this issue. New Mexico is at the forefront of compacting with the Pueblos and Nations when dealing with taxation issues. But there is always room for improvement. As tribes around the US look for ways to increase tax revenue, some have turned to imposing income taxes, some have turned to imposing property taxes. That should not be. In collective cultures, where individual exclusive use and ownership is a foreign concept, taxing is not possible. Tribes alone should benefit from businesses on their lands. Proceeds from all business activity on tribal land should remain with the tribe and used for the general welfare of the community. As previously stated, we are fortunate to have New Mexico as our neighbor. They have a better understanding of the tribal/state relationship than many if not most other states. There is room for improvement of course, but there always is.

So, in addition to business licenses and gross receipts tax collection, as well as the other taxes collected; these are issues we address every day in the tax office. The goal being the long-term economic self-sufficiency of this community.



### Utility Authority Department

The Utility Department has been in operation for a couple of years. The department oversees the Water and Waste Water of the Pueblo. Maintains the wells and lift stations for the Pueblo.

The Utility Department is overseen by the Director, Steven Trujillo. Water Utility Supervisor Brian Suazo, Office Manager Crystal Pino, Wastewater Supervisor Rodeny Talcott, we currently have vacancies for 2 Operator Trainees.

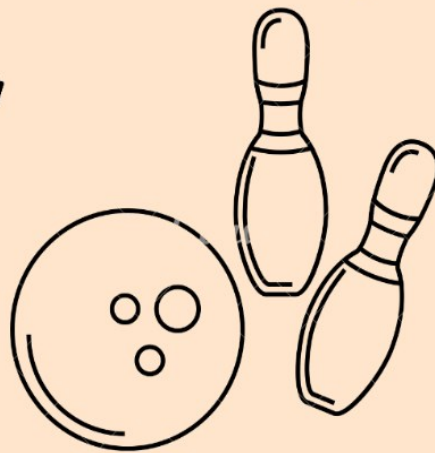

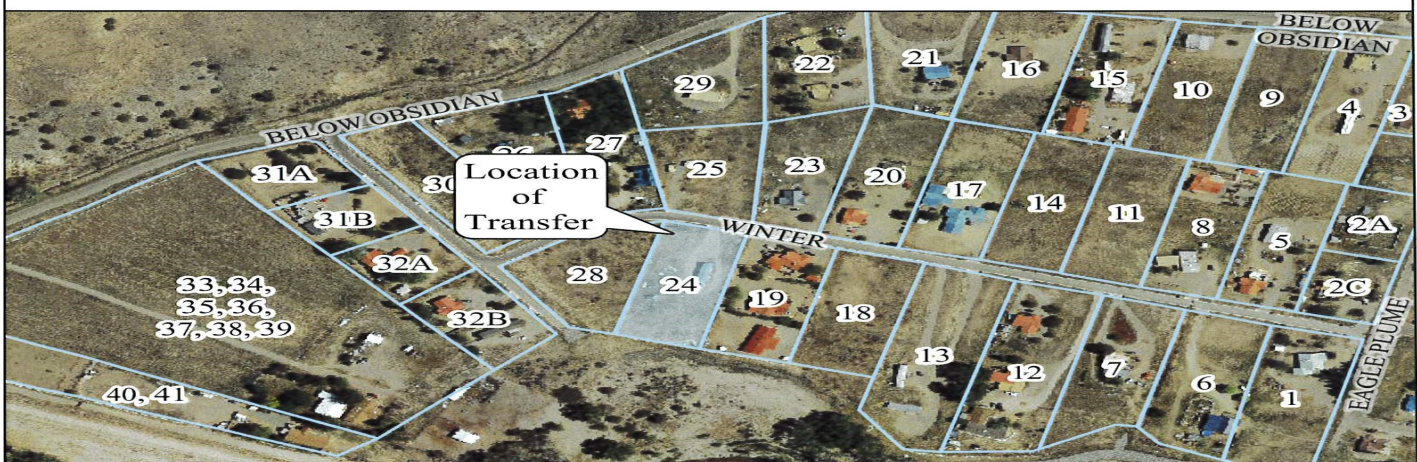

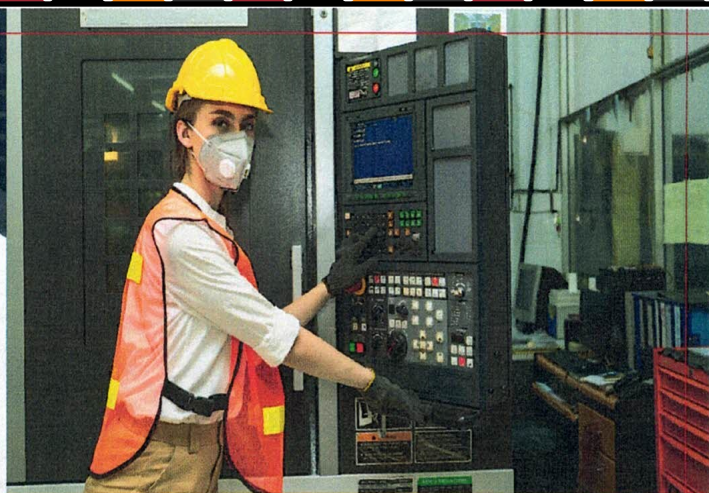

## ENERGY EMPLOYEES OCCUPATIONAL ILLNESS COMPENSATION PROGRAM (EEOICPA)



Office of Environment, Health, Safety and Security

### About EEOICPA

The Energy Employees Occupational Illness Compensation Program Act (EEOICPA) was enacted in October 2000. Part B of the EEOICPA, effective on July 31, 2001, compensates current or former employees (or their survivors) of the Department of Energy (DOE), its predecessor agencies, and certain of its vendors, contractors and subcontractors, who were diagnosed with a radiogenic cancer, chronic beryllium disease, beryllium sensitivity, or chronic silicosis, as a result of exposure to radiation, beryllium, or silica while employed at covered facilities. Part E of the EEOICPA (enacted October 28, 2004) compensates DOE contractor and subcontractor employees, eligible survivors, and uranium miners, millers, and ore transporters as defined by RECA Section 5, for any occupational illnesses that are causally linked to toxic exposures in the DOE or mining work environment.

### Eligibility

#### Eligibility-Part B

- Federal employees of the Department of Energy (DOE), its contractors or subcontractors who worked at a covered DOE facility during a covered time period
- Employees of atomic weapons employers
- Employees of beryllium vendors
- Uranium workers previously awarded benefits by the Department of Justice under Section 5 of the Radiation Exposure Compensation Act (RECA) for the same covered illness
- Certain Survivors\*

#### Eligibility-Part E

- DOE contractors and subcontractors, or certain survivors
- Uranium miners, millers, and ore under Section 5 of the Radiation Exposure Compensation Act (RECA).



## Conditions Eligible for Compensation

### Eligibility -Part B

- Radiogenic cancer
- Chronic Beryllium Disease
- Beryllium Sensitivity
- Chronic silicosis

### Eligibility-Part E

- An illness that was at least as likely as not that occupational exposure or a toxic substance was a significant factor in causing, contributing to, or aggravating the illness or death of an employee.

## Benefits

### Benefits-Part B

- A lump sum amount of \$150,000
- Payment of medical expenses from the date a claim is filed. If the employee is no longer living, the lump sum is payable to eligible survivors\*.
- Employees of the Department of Energy, its contractors and subcontractors who were exposed to beryllium on the job and now have beryllium sensitivity will receive medical monitoring to check for Chronic Beryllium Disease.
- Lump sum amount of \$50,000 and payment of medical expenses from the date a claim is filed is available for uranium workers (or their survivors) previously awarded benefits by the Department of Justice under Section 5 of the Radiation Exposure Compensation Act.

### Benefits-Part E

- Wage Loss, Impairment and medical benefits.
- Under Part E variable compensation up to \$250,000 is determined based on wage loss, impairment, and survivorship.

## How to File a Claim

The US Department of Labor, Division of Energy Employees Occupational Illness Compensation (DEEOIC) has made a variety of mechanisms for application such as on-line, via U.S Mail or through one of DOL resource centers.

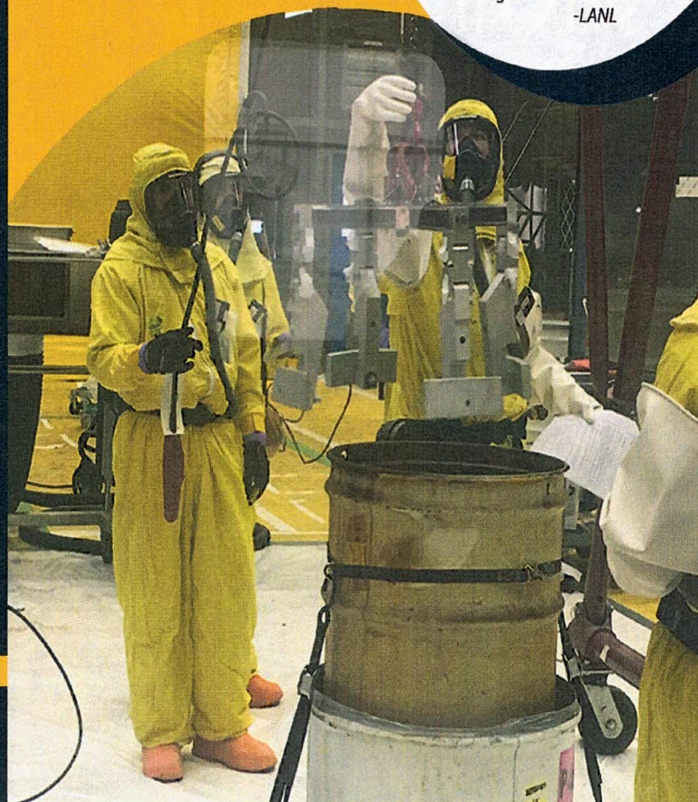

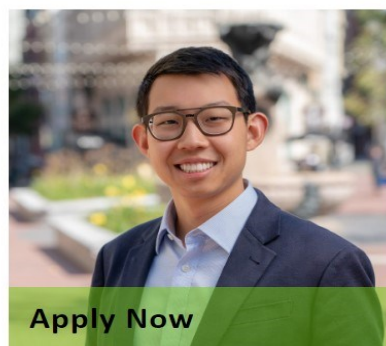
