Un Saengi Thamu, Good Morning My Fellow Veterans and Spouse plus Families of Kha'po Veterans

A number of our Veterans' from Kha'po have begun to meet to talk about and to address a number of Veteran's issues that are of concern to all of us.

We will try to be consistent on our meeting days, times and locations so there will not be confusion and you can plan your involvement.

Although we know there are a large number of Veterans' in our Pueblo including the surviving spouses and your children, we do not know the true number. So we are asking you to contact Virginia Halfmoon at 505-692-6312 ofc, 605-929-7061 cell or at [vhalfmoon@santaclarapueblo.org](mailto:vhalfmoon@santaclarapueblo.org) so we can begin to get an accurate tally of all of our Veterans here at Kha'po.

If you are not aware, there are many Veteran's issues plus benefits that could benefit you or your spouses and families. Attached are a few issues that we could begin with, the PACT Act benefits for Gulf War era and post 9/11 Veterans, VA Health Care along with IHS, VA Burial information with pre-need determination, VA Home Loans for new home construction and renovations, Suicide Prevention and military information requests for DD214 and military medical records, to name a few.

I felt like many of you Fellow Veterans' in applying for Benefits and waited a number of years to apply. Then I attended a Veteran's Meeting here at the Senior Center two years ago and personally asked the presenters why our Veterans' were not being helped and they told me, first we have to hear from you and secondly you have to submit an application for the specific benefits you are seeking.

Today I am receiving medical assistance, and I am now receiving financial benefits because one of Veteran's Representative took the time to help me fill out the appropriate application and forms to assist me. If Judy and my children were minors, they would also have received assistance.

So, I am telling you honestly all of you need to participate and get the appropriate Veteran's forms to apply for various types of assistance and there is a Veteran's Representative to help you get the necessary support to do this.

So please contact Virginia Halfmoon or call me at 505-469-2646 and I can point you in the right direction. I finished my service time in 1970, relieved from Naval Reserve time in 1972, is a Vietnam Veteran and it took me all those years to get this assistance.

There is no guarantee, but you as a Veteran must take the first step. A salute to all of you that served.

In the evening, the plan is to hold a Veterans Day Event for Veterans and spouse and widows and widowers of Veterans at the at the Santa Claran beginning with a dinner at 5:30. Speakers will include members of the Veterans Administration and New Mexico Department of Veterans Services who can offer various benefits to Santa Clara Veterans. So far, those are the broad goals discussed during the Veterans planning meeting and we need your help to develop the details. We still have so much to discuss so additional Veterans planning meetings will be held on, mostly, a weekly basis so that everything can be kept on schedule. Veteran planning meetings will be announced on the electronic bulletin boards by Headstart and at South Housing.

The Veterans Honoring Calendar is on track to be completed in time to be given to the Veterans at the dinner on Veterans Day. Thirty-four Veteran photos have been contributed to include in the calendar along with some amazing images of military activities to serve as background to the photos. The Veterans' planning meeting has also discussed the process of distributing calendars to the Pueblo. No finalized method has been decided at this time.

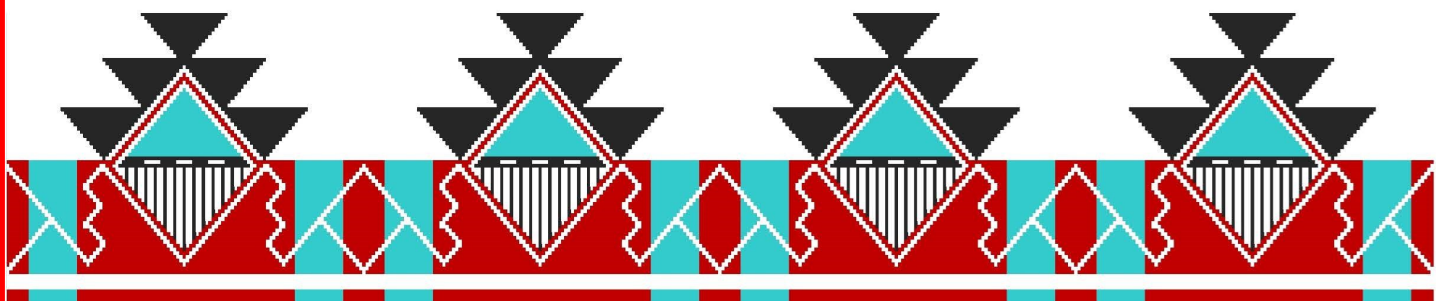
### SEPTEMBER 14, 2024

## Tribal Transportation Program

Greetings Community Members:

The Tribal Transportation Program (TTP) is moving forward with projects; currently awaiting Federal Highway Administration approval of the Puye Road Repair Project plan sets to proceed with advertising the project for construction. The goal is to replace the culvert during early Spring 2025 and repair the eroded section of the road thereafter. Additionally, the contract construction documents for bid submittals are in the approval phase for the "Blue Bus" Stop (shelters) Improvement Project. The date for construction has yet to be determined.

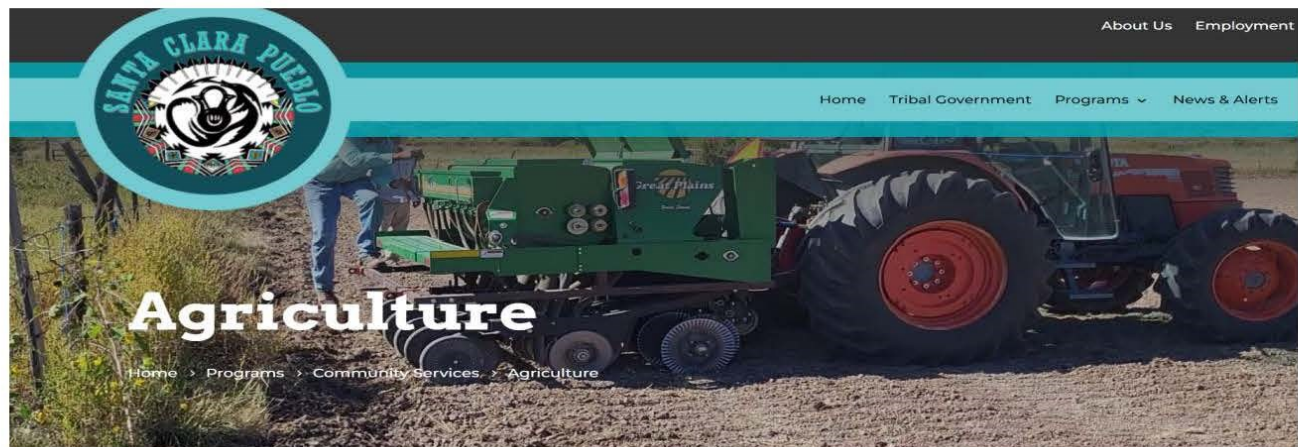
The North Central Regional Transit District (NCRTD) is proposing Blue Bus service changes that include restoring multiple routes in the northern region following service reductions because of the pandemic. Some of the proposed changes include restoring service hours for Route 100 Riverside, restoring Westside Crosstown suspended route, restoring Route 160 Santa Clara to improve efficiency and reduce travel times to and from Santa Fe, eliminating Route 500 Tribal Combined. Proposed changes will require public input in the form of stakeholder presentations, online surveys, events, meetings, prior to public hearing and NCRTD Board approval.

There has been an increase in unauthorized signage (Yard Sale, Food Sale, etc.) on the medians, posted road signs, and cattle guard wings along State Road 30. The New Mexico Department of Transportation (NMDOT) informs us that state law prohibits any person from placing, maintaining, or displaying unauthorized signs, signals and markings upon any state right-of-way. Please be advised that any item that impedes the roadway or right-of-way can be considered a safety issue to pedestrians, bicyclists, and motorists.

Request that you please continue to notify me of any 911 address updates. Tribal members may request a letter for proof of residency, at which time your address will be verified and the request for a letter will be submitted to the Governor's Office.

## **Tribal Self Governance, Agriculture Program in Partnership with Forestry in Designing and Developing a Seedling and Community Garden Project**

Good Day Everyone.

For your information, our Tribal Agriculture Department, with support of Self Governance DOI funds and in partnership with Forestry, has plans for designing and developing a “Community Garden” where our Tribal Community Farmers including our kiddos from our school, can grow our own Corn, Melon, Chili, and many other crops. We are also setting up a Seed Bank, to house and store seeds for melons, corn, and chili, which will be free to Tribal Farmers, to use for their own home gardens if interested. In addition, Forestry’s is working on a seedling project, growing Douglas Fir, Pine Trees, and other trees. The seedling project will come together in the future, as one of our major partnership projects of the Agriculture and Forestry community initiatives. Together these projects are working towards Food Sovereignty, Food Safety, and Grow Your Own Concept, for our Tribal Community and others, as well as providing a reforestation source.

We are looking for Volunteers to help with this initiative, if you have an interest in becoming one of our Volunteer Community Garden farmers, please call Ken at 505-901-8508 or Gilbert at 505-901-8485. We are also interested in forming an Agriculture Advisory Committee to help with ideas and planning for designing our Community Garden. We need the Advisory Committee’s help with ideas and suggestions on what to plant, how much to plant, harvesting, irrigation, and many others.

If you are interested, please stop by our Self Governance Office, and visit with Kenneth Reid, Director, Self Governance & Agriculture Program, or Gilbert Naranjo, Farm Tractor Operator Supervisor, as well. You may also talk with Daniel Denipah, Director, Forestry, if your interested in the seedling project as well.
