WHERE WE ARE LOCATED:

The Behavioral Health department is located at 360 Fog Road behind the Santa Clara Head Start. The Behavioral Health Department has a total of 3 Buildings: (1) Training facility where group counseling and classes are held; (2) Main Office housing the Program Coordinator, Office Manager, and Outreach Coordinator; (3) Behavioral Health Clinic houses the department's Therapist and Case Manager which includes an art therapy room, children's therapy room, and a Tele Behavioral Health room.

HOURS OF OPERATION

The Behavioral Health Department is open Monday through Friday from 8 AM to 4:30 PM. At this time all sessions/ appointments are being offered in person.

MEET OUR TEAM:

Jennifer P. Vigil, Director is a Licensed Alcohol and Drug Counselor. She has been with the Santa Clara Behavioral Health Department for the last 9 years and has enjoyed providing services to the community of Santa Clara Pueblo. She was born and raised in Espanola, New Mexico and has dedicated over 30 years in fighting the battle of addictions. She has seen many successes and have seen good people lose their battle to the deadly crisis of addictions. Jennifer has made a commitment to do her best to provide Professional, Confidential, Individual and Sensitive treatment for each community member who seeks out our services. I believe that together we can be one another's gate keeper.



Melanie Jo Montoya, Program Coordinator for the Behavioral Health Program. She has been employed with the program for 8 years. She is an enrolled tribal member of Santa Clara Pueblo. Prior to coming on board with the Behavioral Health Program, Melanie worked with the Santa Clara Pueblo Special Projects Department for many years. Melanie assists with the daily operation of the Behavioral Health Program and works closely with all tribal and surrounding communities on referrals to the Behavioral Health Program, that includes all administrative responsibilities such as assisting with case management, advocacy, and record keeping & reporting on services provided to Funding Agencies and Tribal Council to name a few. She is also certified to meet the needs of Parenting Courses for our community through the UNM Community of Behavioral Health Division.

Barbara Rodriguez, Office Manager for the Behavioral Health Program. She has been employed with the program for 9 years. She is an enrolled member of San Felipe Pueblo, but calls Cochiti Pueblo her home. Barbara is the backbone of our program, as she ensures all Administrative functions, Medicaid funding, and grant requirements are met. She is a certified Presumptive Eligibility Determiner (PED) for Medicaid and a Medicaid biller. Barbara calls La Puebla home and has for the past forty years.

Anita Vigil, LCSW Clinical Supervisor She has been employed with the program for 6 months. Anita is the daughter of a Bataan Death Survivor Prisoner of War. Anita experienced early on the impact of trauma of an individual's life. She became interested in helping people live more satisfying lives. Anita graduated with her Masters Degree in Social Work. She's been a counselor for 45 years. She's been trained in trauma, processing, mindfulness, and CBT (Cognitive Behavioral Therapy). Her particular interest is to empower women. Anita also provides play therapy for children dealing with behavioral traumatic issues. One of her main goals in working with individuals is to teach them self regulation which enables to have happy lives, positive relationships, and help with their emotional journey through life. Anita always make sure people receive unconditional positive regard in a nonjudgmental environment.

Dolores Rivera, Case Manager/CHR Generalist. She has been employed with the program for 1 year. Dolores has been assisting individuals with entry into the outpatient program, along with providing supportive services on behalf of an individual's treatment plan. She's been employed in the treatment field for three decades; following in the footsteps of her father, Porfirio Rivera, a charter board member of Rio Grande ATP, also known as "Embudo". The lessons she learned growing up as the daughter of an alcoholic taught her so much. She has extensive experience Working in outpatient programs, male and female/child residential facilities, inpatient hospital treatment and with Job Corps Intervention Program. Lessons have been shared through empathy and connection to those that she worked with, past, present, and future. She's learned to accept that she was in place for those that were ready to seek assistance, "She didn't do it for them, they did it themselves." Making the decision to choose sobriety and follow the path to recovery has brought tears of joy, sadness, and learned optimism. She hopes to be of assistance to many individuals in the future.

Martina Montoya, Outreach Coordinator Martina is a dedicated member of the Behavioral Health Program, having contributed her skills for 7 months. As an enrolled tribal member of Ohkay Owingeh, she holds a deep commitment to her community. With 2 years of experience at the Santa Clara Clinic, Martina tirelessly advocates for the program by spreading vital information to local communities. She is a certified QPR (Question, Persuade, Refer) Suicide Prevention Gatekeeper Instructor, and she also holds certifications in Acupuncture (Ear Seeding) and Naloxone administration.

SANTA CLARA PUEBLO SOCIAL SERVICES PROGRAM

The Santa Clara Pueblo Social Services objective is to improve the quality of life for tribal community members of Santa Clara Pueblo and to protect the children, the elderly, and disabled from abuse and neglect. The Program also supports at-risk families to allow children to remain with their families.

Our Program consists of Welfare Assistance which includes Burial and General Assistance and Foster Care. The Program also implements the Indian Child Welfare Act (ICWA). The purpose of the Indian Child Welfare Act is "to protect the best interest of Indian Children and to promote the stability and security of Indian tribes and families for the removal of Indian children and placement of such children in homes which will reflect the unique values of Indian culture". ICWA is a Federal Law which was enacted after the Federal Government recognized that American Indian children were being removed from their homes and communities at a much higher rate than non-Native children.

Social Services also participates in Community Outreach; Prevention and Awareness activities; and collaborative efforts with other Tribal departments and outside Agencies that may benefit the children and families of our Pueblo. We provide referrals to our Behavioral Health Program for Parenting Classes and encourage Tribal foster home recruitment and retention to become licensed within the exterior boundaries of Santa Clara Pueblo which includes Foster Parent trainings at least twice a year.

Our Staff consists of our Director, Terrie Chavarria who has been with the Program for 16 years, as an ICWA Worker, a Tribal Social Caseworker and is now our Director. We also have Ann F. Gutierrez, Office Manager, who has worked for the Program for 12 years; and Jacqueline Wright, our Tribal Social Caseworker, who has been with us for 4 years and has extensive experience in child welfare.


Our organization has committed to recording all archaeological features on the mesa, including over 100,000 petroglyphs made by the Indigenous peoples of the area. As an intern, you'll help document these features and petroglyphs while learning skills which include:

- Use of GPS units and more!

Bandelier's Summer Shuttle Service Begins on May 14, 2025

Los Alamos, N.M. – Bandelier National Monument is beginning its free summer shuttle service to Frijoles Canyon on May 14, 2025. The shuttle, provided by [Atomic City Transit](#), boards at the Frey Trail Parking Lot in the park and runs every 10 minutes starting at 10 am.

Unlike previous years, the shuttle is not mandatory unless the parking lots in the canyon are filled up. Also, there will be no shuttle service to the White Rock Visitor Center. Shuttle services will only operate between parking areas within Bandelier. Visitors are encouraged to stop by the White Rock Visitor Center for information on regional attractions and unique exhibits. Visitors may use the free shuttle to access trail heads on the mesa top and will provide easy access between the Bandelier National Monument Visitor Center and Juniper Campground.

There is no charge for riding the shuttle, but all normal [entry fees](#) still apply for entering the park. Fees are based on the vehicle visitors arrive to the shuttle in, which is not a per person basis usually. If a visitor has a valid America the Beautiful or Bandelier pass, then no entry fees need to be paid.

The park's summer shuttle service is expected to end on October 14, 2025.
