TITLE XVI - CULTURAL AND NATURAL RESOURCES

CHAPTER 91 - WILDLIFE CONSERVATION

SUBCHAPTER A - General Provisions

Sec. 91.A. 1 Definitions

1. "Adult" means a person eighteen years old or older.
2. "Aquatic wildlife" means fish, crustaceans, aquatic insects, or amphibians.
3. "Bag limit" means the maximum number of wildlife which may be lawfully taken or possessed by any one person in any one day.
4. "Carcass" means the dead body of any animal or parts of it.
5. "Closed area" means an area of land where hunting or fishing for wildlife is prohibited.
6. "Closed season" means that period of time during which the taking of wildlife is prohibited.
7. "Conservation Officer" means an officer supervised by the Enforcement Division Head who is responsible for enforcement of this Chapter.
8. "Cultural Sites or Properties" means any place, object, or structure on Pueblo lands with cultural, religious, or historic significance to the Pueblo.
9. "Enforcement Division" means the Santa Clara Pueblo Natural Resources Enforcement Division.
10. "Enforcement Division Head" means the person responsible for supervision of the Enforcement Division.
11. "Firearm" means a handheld device that fires a projectile with the use of gunpowder, including pistols, revolvers, rifles, shotguns, and the like.
12. "Fishing" means to taking or attempting to take aquatic wildlife.
13. "Hunting" means to taking or attempting to take non-aquatic wildlife.
14. "Indian" is defined at Chapter I, Section 1.1 of this Code.
15. "Legal hunting and fishing hours" means one-half hour before sunrise until sunset, unless otherwise provided by Enforcement Division rules and regulations adopted by the Council.

16. "Minor" means any person less than eighteen years old.
17. "Motor vehicle" means any self-propelled vehicle, including an all-terrain-vehicle (ATV) or a snowmobile.
18. "Non-tribal member" means any person who is not enrolled as a member of the Santa Clara Pueblo.
19. "Officer" means a Conservation Officer or Law Enforcement Officer, as defined under Chapter VIII of this Code, of the Pueblo.
20. "Permit" means a document issued by the Enforcement Division, including a license, tag, or other document, which authorizes the taking of wildlife or grants permission to engage in any other activity covered by this Chapter.
21. "Possession" means actual or constructive possession.
22. "Possession limit" means the maximum number of wildlife that may be possessed by any one person at any one time.
23. "Pueblo lands" means lands owned by the Pueblo subject to restriction against alienation imposed by federal law or held in trust for it by the United States.
24. "Tag" means a card, label or other identification device issued by Enforcement Division for attachment to the carcass of any wildlife as evidence of legal taking and custody.
25. "Take" means to capture, kill, or possess wildlife, including by means of a trap or net.
26. "Council" means the Santa Clara Pueblo Tribal Council.
27. "Tribal Court" means the Santa Clara Pueblo Tribal Court.
28. "Member" means a person who is an enrolled member of the Santa Clara Pueblo.
29. "Pueblo" means the Santa Clara Pueblo.
30. "Wildlife" means any animal that is not domesticated.

SUBCHAPTER B - Natural Resources Enforcement Division

Sec. 91.B. 1 Establishment of Division

There is hereby created a Natural Resources Enforcement Division. The Enforcement Division shall be supervised by an Enforcement Division Head.

Sec. 91.B. 2 Enforcement Division Head

The Pueblo Sheriff shall be the Enforcement Division Head unless another person is appointed by the Governor with the concurrence of the Council.

Sec. 91.B. 3 Authority of Enforcement Division

The Enforcement Division shall have the authority to enforce the provisions of this Chapter and to recommend appropriate rules and regulations under this Chapter for adoption by the Council.

Sec. 91.B. 4 Appointment of Conservation Officers

Conservation Officers shall be appointed in accordance with Chapter VIII of this Code.

Sec. 91.B. 5 Authority of Officers

1. Conservation Officers shall have the power and authority of a Law Enforcement Officer for the purpose of enforcing the provisions of this Chapter and any regulations adopted by the Council, including the authority to make arrests and to conduct searches and seizures. Law Enforcement Officers of the Pueblo shall also have the authority to enforce the provisions of this Chapter.

2. Officers may inspect all wildlife taken as well as all equipment used to take the wildlife. Officers may also search without a warrant any vehicle, boat, box, building, hunting camp, fishing camp, game bag, or other package found on Pueblo lands where the officer has probable cause to believe that wildlife or parts thereof are possessed in violation of this Chapter, provided that a home or permanently occupied dwelling shall not be entered or searched without a search warrant.

Sec. 91.B. 6 Fish and Wildlife Regulations

The Enforcement Division shall recommend rules and regulations for adoption by the Council to implement the provisions of this Chapter, which shall include the rules and regulations governing the following:

1. The seasons for taking any wildlife when it is ascertained that such seasons are necessary to properly maintain wildlife management and control;
2. The permits and tags required for hunting and fishing and any fees or other requirements for obtaining such permits and tags;
3. Any applicable requirements for reporting the number of wildlife taken and the timing for such reporting;

4. Bag limits and possession limits;
5. The means by which different wildlife species may be taken, including the permissible types of baits, lures, tackle, hunting and fishing equipment, traps, firearms, and other weapons;
6. Closed areas;
7. Any applicable safety or fire control measures, as deemed necessary for the protection of wildlife habitat, wildlife management, or the safety and welfare of the Pueblo and those participating in hunting and fishing on Tribal lands;
8. A schedule of civil penalties to be imposed for violations of this Chapter; and
9. Any other provision necessary for the conservation and management of wildlife or necessary to implement the provisions of this Chapter.

Sec. 91.B. 7 Publication of Fish and Wildlife Regulations

Fish and wildlife regulations adopted by the Council shall be published in the Tribal newsletter and shall be posted in the Governor's office. The Enforcement Division shall make a copy of the regulations available upon request to any person.

Sec. 91.B. 8 Emergency Regulations

If it is determined that an emergency situation exists relating to wildlife, the Council may, in consultation with the Enforcement Division Head, adopt emergency regulations to protect the health, safety and public welfare of the Pueblo or its wildlife.

Sec. 91.B. 9 Protecting Livestock

Nothing in this Chapter shall prevent a livestock owner from protecting his or her livestock from predators. If a livestock owner believes it is necessary to violate this Chapter in order to protect his or her livestock from predators, the livestock owner shall immediately inform the Enforcement Division and request an exemption from this Chapter. Any livestock owner who fails to make such a request may be found to be in violation of the applicable provisions of this Chapter or the Enforcement Division rules and regulations. If any livestock has been killed by a predator, the Enforcement Division shall notify the owner of the livestock, if such owner can be identified. If the killed livestock is unbranded, disposal of the livestock shall be left to the discretion of the Enforcement Division Head. If a livestock owner discovers livestock that has been killed by a predator, he or she shall inform the Enforcement Division.

SUBCHAPTER C - Hunting and Fishing

Sec. 91.C. 1 Enforcement Authority

The Enforcement Division shall have responsibility for enforcing this Chapter and applicable rules and regulations governing hunting and fishing.

Sec. 91.C. 2 Tagged Animals

Hunters shall report all tagged wildlife to the Enforcement Division. The Enforcement Division shall transmit information about wildlife tagged by state or federal agencies to those agencies.

Sec. 91.C. 3 Documenting and Reporting Major Disturbances

Conservation Officers shall document and report to the Division Head any major disturbances to wildlife or wildlife habitats, including mass deaths of wildlife, diseases, insect infestations, and contamination of waters or other wildlife habitats.

SUBCHAPTER D - Hunting by Minors

Sec. 91.D. 1 Accompaniment of Minors

A minor may hunt only when accompanied and supervised by an adult.

Sec. 91.D. 2 Hunter Safety Training Course for Minors

A certificate indicating successful completion of an approved hunter safety training course is required for a minor to obtain a hunting permit. A minor shall also carry his or her certificate at all times when hunting or shooting a firearm. Approved hunter safety training courses include hunter safety training courses provided by the Enforcement Division or any state or National Rifle Association-approved course.

SUBCHAPTER E - Camping, Hiking, and Picnicking

Sec. 91.E. 1 Camping

The Enforcement Division shall have responsibility for campsites on Pueblo lands. Such responsibilities shall include maintaining the condition and safety of campsites, enforcing applicable provisions of this Chapter governing littering and fires, and enforcing any other applicable rules and regulations.

Sec. 91.E. 2 Trails and Roads

The Enforcement Division shall be responsible for monitoring and maintaining trails on Pueblo lands for safety and access. The Enforcement Division shall also be responsible for monitoring roads in the Santa Clara Canyon for safety and access, but maintenance of those roads shall be the responsibility of the tribal roads crew.

Sec. 91.E. 3 Littering

Persons engaged in camping, hiking, picnicking, or other outdoor recreation shall not leave trash or litter, except in proper receptacles.

Sec. 91.E. 4 Fires

Persons engaged in camping, hiking, picnicking, or other outdoor recreation shall only build fires in a contained and controlled area and shall not leave a fire unattended while any embers or sparks remain, nor shall such persons throw burning matches or any burning material on the ground. The Enforcement Division may establish areas or seasons in which fires are prohibited.

SUBCHAPTER F - Wood and Sand Gathering and Hauling

Sec. 91.F. 1 Wood and Sand Gathering and Hauling

The Enforcement Division is responsible for publishing, implementing, and enforcing regulations governing the gathering and hauling of wood and sand on Pueblo lands, including provisions identifying any required permits, areas where such activities are permissible, and the timing or seasons during which such activities are permissible.

SUBCHAPTER G - Prohibited Conduct

Sec. 91.G. 1 Disobeying a Natural Resources Conservation Officer

It is unlawful for any person to fail to obey a lawful order given by a Conservation Officer in the course of performing his or her duties.

Sec. 91.G. 2 Unlawful Taking or Possession of Wildlife

It is unlawful for any person to take, attempt to take, or possess any wildlife or part thereof, whether or not such wildlife is alive or dead, unless such taking is permitted by and in accordance with this Chapter and Enforcement Division rules and regulations.

Sec. 91.G. 3 Hunting or Fishing Without Required Permit or Tag

It is unlawful for any person to hunt or fish without having all required permits or tags in his or her possession.

Sec. 91.G. 4 Failing to Tag Wildlife Properly

It is unlawful for any person to fail to tag wildlife as may be required by this Chapter or the related regulation.

Sec. 91.G. 5 Hunting or Fishing Outside Legal Hours

It is unlawful to hunt wildlife or fish other than during legal hunting and fishing hours.

Sec. 91.G. 6 Hunting or Fishing during Closed Season

It is unlawful for any person to hunt or fish during a closed season.

Sec. 91.G. 7 Hunting or Fishing in a Closed Area

It is unlawful for any person to hunt or fish in a closed area.

Sec. 91.G. 8 Exceeding Bag or Possession Limits

It is unlawful to take or possess wildlife in excess of the established bag limits or possession limits.

Sec. 91.G. 9 Altering or Transferring a Permit

It is unlawful for any person to alter or copy his or her permit, or to transfer, sell, loan, or assign his or her permit to another person.

Sec. 91.G. 10 Using Illegal Firearms or Ammunition

It is unlawful to hunt or fish using firearms, ammunition, or other equipment that is prohibited by Enforcement Division rules and regulations.

Sec. 91.G. 11 Spotlighting

It is unlawful for any person or group of persons to take or attempt to take wildlife with the aid of a spotlight or other artificial light, unless authorized by the Enforcement Division.

Sec. 91.G. 12 Hunting from Motor Vehicle

It is unlawful for any person to shoot at wildlife from a motor vehicle.

Sec. 91.G. 13 Damage to Cultural Sites or Properties

It is unlawful to damage or alter Cultural Sites or Properties or to remove any items from such sites or properties.

Sec. 91.G. 14 Driving Off Established Roads

It is unlawful to drive off of established roadways, except when reasonably necessary for purposes of lawfully collecting natural resources, including collecting firewood, gathering piñon nuts, or retrieving game animals. Any person who drives off of established roadways for such purposes shall exercise great care to minimize damage to the natural environment and shall avoid causing any damage whatsoever to Cultural Sites or Properties.

Sec. 91.G. 15 Hunting or Possessing a Firearm While Under the Influence of or Impaired by Alcohol or Drugs

It is unlawful for any person to hunt or to possess a firearm while under the influence of or impaired by alcohol or any other drug or narcotic.

Sec. 91.G. 16 Shed Antlers

It is unlawful for any person to gather shed antlers from Pueblo lands for purposes of sale or trade, except that Indians are permitted to gather and trade shed antlers with other Indians.

Sec. 91.G. 17 Wood and Sand Gathering and Hauling

It is unlawful for any person to gather or haul wood or sand on Pueblo lands not in accordance with any applicable rules and regulations. It is unlawful to sell wood or sand gathered on Pueblo lands, unless such sale is authorized by applicable rules and regulations.

SUBCHAPTER H - Penalties

Sec. 91.H. 1 Civil Penalty Schedule

The Council has, with the advice of the Enforcement Division, adopted a schedule of civil penalties to be imposed for violations of this Chapter, which is found at Appendix A of this Code.

Sec. 91.H. 2 Citations

Conservation Officers may issue citations and civil penalties for violations of this Chapter. Such citations must inform the violator of the option to pay the civil penalty or to appear before the Tribal Court at a time and place identified in the citation. If the Tribal Court determines that a person violated this Chapter, the Tribal Court may assess a civil penalty in accordance with the schedule of civil penalties adopted under this Chapter.

Sec. 91.H. 3 Criminal Penalties

In addition to any other penalties allowed under this Code, any Indian who violates any of the sections in Subchapter G - Prohibited Conduct, shall be guilty of a crime and, upon conviction thereof, shall be sentenced to confinement for a period of not more than one year or to pay a fine of not more than \$5,000.00 or both, with costs.

Sec. 91.H. 4 Denial, Suspension and Revocation of Permit Privileges

The Enforcement Division has the authority to deny, revoke, or suspend a permit for a period of time not to exceed five (5) years for an initial violation, and up to a lifetime suspension for a second violation, if it is determined that a person has:

1. Violated this Chapter;
2. Been convicted of a state, federal, or tribal wildlife violation; or
3. Made material misrepresentations in applying for a permit.

Notice of any denial, suspension or revocation shall be sent to the holder of the permit by certified mail, return receipt requested, to the last-known address of such person. Such notice shall inform the person of his or her right to appeal.

Sec. 91.H. 5 Persons Prohibited from Receiving Hunting Permit

Under no circumstances shall a hunting permit be issued to an individual who has been convicted in any jurisdiction of a felony or a crime of domestic violence.

Sec. 91.H. 6 Non-Tribal Members

In addition to any applicable civil penalties, any non-tribal member who violates this Chapter may be considered to be trespassing on Pueblo lands and is subject to exclusion.

Sec. 91.H. 7 Revocation of Other Privileges

A person who has violated this Chapter may also have their privileges to gather and haul wood or sand revoked.

Sec. 91.H. 8 Statute of Limitations

The statute of limitations for all civil actions arising under this Chapter is five years from the date of the commission of the violation of this Chapter.

Sec. 91.H. 9 Possession as Presumptive Evidence

The possession of wildlife shall be presumptive evidence that the person having such possession is engaged or has been engaged in hunting or fishing.

Sec. 91.H. 10 Seizure

At the time a citation is issued for violation of this Chapter, the officer may seize any firearm, weapon, or equipment used in the taking of wildlife or otherwise involved in the commission of the violation for which the arrest was made or citation was given and shall give the person from whom such things were taken an itemized receipt for all seized items. All wildlife allegedly taken or possessed illegally is the property of the Pueblo and may be seized by an officer.

Sec. 91.H. 11 Forfeiture

1. When a person is found to have violated this Chapter, the Tribal Court, in addition to imposing other penalties, may order the forfeiture to the Pueblo of all or part of the seized items owned by the offender if the Tribal Court determines such forfeiture is reasonably necessary to prevent future violations of this Chapter by the offender or to protect the health, safety, and welfare of the Pueblo or its Members.

2. If the seized items are not owned by the offender, the Tribal Court may order a preliminary forfeiture. The Tribal Court shall give notice to the owners of the seized property and provide an opportunity for a hearing before ordering the forfeiture to the Pueblo of the seized items. At such hearing, the burden shall be on the owners of the seized items to prove they did not participate in or have knowledge of or consent to the illegal use of the seized items.

Sec. 91.H. 12 Disposition of Confiscated or Forfeited Items

Confiscated wildlife may be donated or sold by the Pueblo and, if sold, any proceeds shall be deposited in the general funds of the Pueblo.

SUBCHAPTER I - Appeals

Sec. 91.I. 1 Administrative Appeal

1. A person, whose permit privileges have been denied, suspended, or revoked may institute a review of such action by the Tribal Court by filing a written notice of appeal in the Tribal Court and sending a copy to the Enforcement Division, within thirty (30) days of the denial, suspension, or revocation.

2. The Tribal Court shall set a hearing date no more than twenty (20) working days following receipt of the notice of appeal.

3. The Tribal Court shall issue all decisions in writing within ten (10) working days of the hearing.

4. The Tribal Court shall have the authority to affirm or reverse the denial, suspension or revocation, and to shorten or lengthen the suspension or revocation period.
