The schedule below of the irrigation systems will be in effect so all individuals who irrigate will benefit from the water. Please note that water may be turned off from time to time for cleaning or during inclement weather to prevent sediment from clogging the system.

Main concrete ditch

Monday & Tuesday

People who have fields **North** of Mr. Joseph G. Naranjo and Mr. Jesse Gutierrez (Hump Road) will have use of the irrigation waters.

Wednesday

All people that have fields along the middle ditch will have use of the irrigation waters.

Thursday, Friday & Saturday

People who have fields **South** of Mr. Joseph G. Naranjo and Mr. Jesse Gutierrez (Hump Road) will have use of the irrigation waters.

Sunday

The irrigation water will be open for use by anyone desiring to irrigate.

Santa Clara Canyon Ditch

Guachupangue- Sunday Midnight to Tuesday Noon

People will have the use of the irrigation waters.

Tuesday Noon to Wednesday Noon

People who have fields between old Santa Clara Canyon head gate and Guachupangue head gate will have usage of the irrigation waters.

Wednesday Noon to Thursday Noon

People who have fields between the Guachupangue head gate, to include the Holcomb ditch, will have use of the irrigation waters.

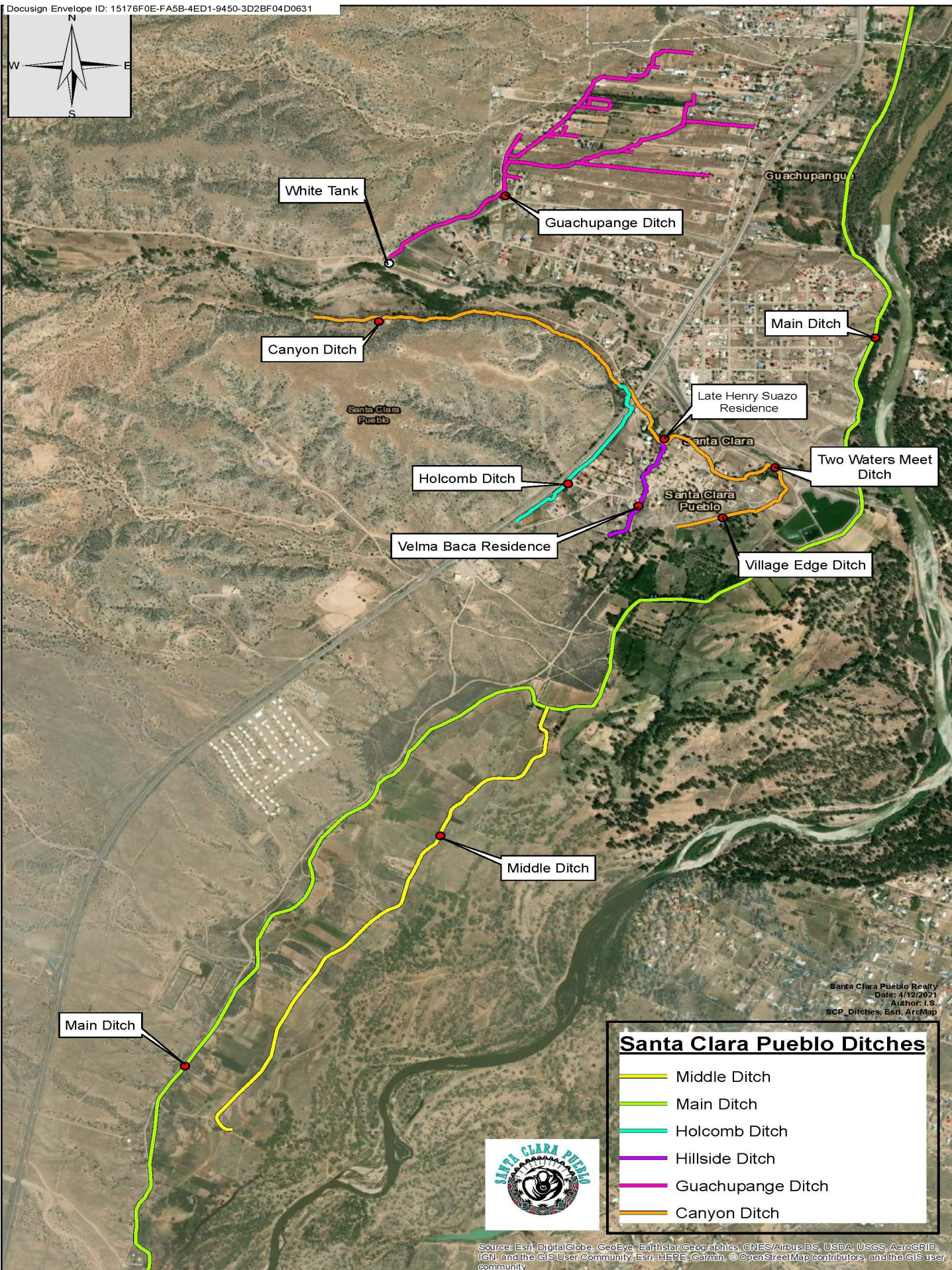
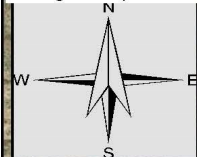
Thursday Noon to Friday Midnight

People who have fields between the Holcomb ditch, including those who have fields using the head gate by the Suazo residence (south) will have usage of the irrigation waters.

Friday Midnight to Sunday Midnight

People who have fields between the head gates by the Suazo residence, including those who use water in the bottom field east of the pueblo will have use of the irrigation waters.

SPECIAL PROJECTS & SAFETY OF DAMS

PROGRAM OVERVIEW

Special Projects & Safety of Dams consist of three full time staff who oversees and manages all capital projects for the Pueblo. Our office includes several programs and serves a multitude of projects. The department also includes four full time staff who are certified and licensed in the Heavy Equipment and Roads Program which maintain all tribal roadways within the tribal boundary to ensure the safety of drivers. These additional duties include vegetation control, road grading, pavement patching, street sweeping and snow plowing. Our office also manages and operates the Canyon and River Irrigation Systems ensuring water is available for tribal members during planting season. In addition, the Safety of Dams Program manages the Flood Early Warning System which our office is capable to provide real time notifications to warn the tribe of potential floods or increase in run-off problems. This system is monitored 24 hours a day and maintained twice a year. Our office is located within the Tribal Administration building and provides an open policy for anyone who requires information, please see staff and contact information below.

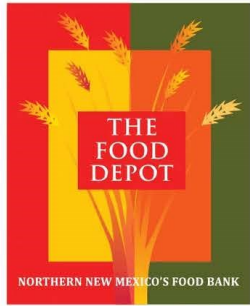

June shines a light on men's health and preventative care

SANTA FE— Men in New Mexico are dying, on average, seven years earlier than women.

During Men's Health Awareness Month this June, the New Mexico Department of Health (NMDOH) urges men to take simple, proactive steps to protect their health and extend their lives.

"Men's Health Month is a vital reminder that prioritizing physical and mental well-being is essential to living longer, stronger, and healthier lives," said **Dr. Miranda Durham**, NMDOH Chief Medical Officer. "We encourage all men to take charge of their health by getting regular checkups, staying active, and seeking support when needed."

Men are more likely to go long periods without seeing their doctor, are more likely to engage in risky behaviors and are less likely to adopt preventive health measures. Other important factors for men's health include:

- Men are almost twice as likely as women to die from heart disease.
- 1 in 8 men will be diagnosed with prostate cancer in their lifetime.
- Men are more likely than women to develop diabetes.
- Men smoke more than women and are more likely to develop lung cancer.
- Men are four times more likely to die by suicide than women. In 2023, NM men were six times more likely to die by suicide than women. That year 403 men died by suicide compared to 67 women.

Many preventive services for men are available at no cost under most health insurance coverage programs including:

- Blood pressure and cholesterol screening.
- Alcohol misuse and tobacco use counseling.
- Type 2 diabetes screening.
- Diet counseling and obesity screening.
- Colorectal cancer screening for men over 45.
- All men should talk to their provider about prostate cancer screening at age 50.
