


25th Anniversary of the Return of P'opii Khanu to Santa Clara Pueblo

"P'opii Khanu has since time immemorial been one of the most cherished and revered sacred areas for our Kha'p'on Towa within our Tewa Bugeh. So, without a doubt, when the opportunity came to regain back this sacred area and surrounding lands, our Pueblo supported the initiative to restore our traditional lands and resources. It was not easy task, but the challenge was a fight with all that were involved to follow steps A to Z to succeed in this restoration because the land and resources were always traditionally ours from what we were told by our Forefathers. Today we are blessed to call this land and its surrounding resources: "Nambi Popii Khanu." – Former Governor Walter Dasheno, 2025.



In life, things can seem impossible. From the 1930's to the 1990's, the older men who hunted in the canyon past 4th pond would run into a fence and gates with signs that read "BACA LOCATION #1, NO TRESPASSING!" It didn't make sense that the rest of our canyon and the springs that created our creek were on the other side of that fence. We would look angrily or sadly at the beautiful mountain forest and flowing creek on the other side and think: "How can we ever get those lands back?" We had every reason to be discouraged.

Since time immemorial, our Kha'p'on T'owa have cared for, used and protected our ancestral homeland in the Jemez Mountains, Pajarito Plateau, and Rio Grande Valley – especially the Santa Clara Canyon. This is our church, our grocery store, our pharmacy because it provided the plants, animals, water, trees and other resources we needed to live.

Then, on December 11, 1860, the U.S. Congress took the most important part of our canyon – the headwaters of the Santa Clara Creek and the lands that surrounded them – and put it in a private ranch. For 137 years, four generations of our people tried various ways to get the land back, unsuccessfully. But our ancestors instilled in our minds that these would always be our lands and we should never give up until our beautiful headwaters and other sacred land had been returned to us.

In the early 1990's, former-Governor Walter Dasheno organized a Land Claims Committee made up former Governor Denny Gutierrez, former Governor Calvin Tafoya, former Governor Frankie V. Gutierrez, former Governor Jose M. Tafoya, Fidel Naranjo, Eugene Naranjo and himself. He also created Land Claims / Rights Protection Program led by Alvin Warren and Gilbert Gutierrez.

On September 24, 1997, the committee and staff learned that the owners of the Baca Ranch (the Dunigan Family) were willing to sell it but only to the federal government. Nevertheless, we believed this was our opportunity. We wrote letters to the President of the United States Bill Clinton, as well as the Forest Service, the Dunigans, and our members of Congress. We told them about how our headwaters had been taken from us and they now had the chance to do the right thing and return it to us.

At first, the Pueblo's letters and requests were ignored. Then we came up with a plan: what if we offered to buy the land back? The only problem was that the Pueblo had very little money back then. Dave Warrren, Alvin's father, knew a foundation called the Lannan Foundation that had just moved to Santa Fe. Santa Clara officials and staff met with the foundation's President Patrick Lannan, Executive Director of Programs Janet Voorhees (who now goes by the name Jaune Evans) and Curtis Berkey, an attorney they hired to research our land claims. We were shocked when the Lannan Foundation told us they'd give us the money to buy the land.

Over the next two and a half years, we overcame many obstacles and also learned that many people were willing to support us. We convinced the White House, the U.S. Department of Agriculture (USDA), the U.S. Forest Service and the U.S. Congress to support our offer to buy back our headwaters at the same time the United States bought the rest of the Baca Ranch. The Dunigans went along reluctantly. Even though the deal fell apart twice, we didn't give up. We kept going to Washington, DC to meet with people, working with our attorneys and lobbyists, and taking people up into the canyon to convince them to help us. Our support grew to include the governor of New Mexico, county commissions, local cattle owners, and thirteen conservationists, sportsmen's, and wildlife groups.



Finally, we negotiated a contract with the USDA that enabled us to purchase our headwaters along with a buffer zone called a conservation easement over additional adjacent lands. In the midst of the tragic Cerro Grande Fire, we fought for language to be added to the "Valles Caldera Preservation Act" so that the federal government would allow us to buy these lands and add them to our reservation.

In the end, we paid \$4.5 million (provided by the Lannan Foundation) to get back ownership to 5,046 acres and a 1,200-acre buffer zone (equal to almost 10 square miles). This was the most land our Pueblo had gotten back in almost a century.

Twenty-five years ago, on July 25, 2000, Santa Clara Pueblo achieved what we had once only dreamed of: a small group of us walked up to that fence, pulled off the "NO TRESSPASSING" signs, and pushed open that gate so that all future generations of Kha'p'on T'owa would be able to use, care for, enjoy and protect its sacred resources. On September 3, 2000, the Santa Clara Tribal Council issued a proclamation thanking more than 63 people who played a key role in the return of P'opii Khanu. The Council also declared that, in recognition of its historic importance, July 25 would be designated "P'opii Khanu Land Recovery Day" and be a recognized as a Santa Clara Pueblo Tribal Holiday into the future.

The Proclamation also said: "It is our hope that this event marks the beginning of a new era of cooperation between the Pueblo of Santa Clara, the federal, state, and local governments, private entities and organizations, and our neighbors which will lead to the increased protection and recovery of our Ancestral Homeland." In fact, Santa Clara has continued to regain more of our lands, including Bureau of Land Management land and other lands in the Garcia Canyon and the Water Serpent Ranch. This is #Landback before that term came to be used. We should be very proud of our Pueblo for never giving up and for fighting so hard to regain and protect our ancestral homeland. With prayer, hard work and the support of other people, anything is possible.





Accounting/Procurement Department

Happy July from the Accounting/Procurement Department!!

The Accounting/Procurement Department continues to provide accounting/procurement services to all Santa Clara Pueblo departments who receive Federal and State, local, funding as well as the Pueblo's General Fund.

The department is responsible for the financial management in accurately identifying revenue received from these entities and accurately identifying costs incurred by these Federal and State funded programs. The Pueblo is a Self-Governance tribe and all programs are administered and accounted for at the Tribal level.

The department is audited annually on all federal and state funds received. The Tribal Council requires an annual audit of the general fund as well. All audits are performed by an independent CPA firm and the Pueblo's financial statements are prepared by the Department with the assistance of financial consultants. The 2023 audit is was completed in September of 2024 with no findings. The 2024 audit is currently being conducted with a deadline to complete and submit by September 30, 2025. All prior year audits have been completed on time with no findings.


I supervise Mr. Lucas Willow who holds the position of "Property Specialist". We currently have two open positions an Accounting/Procurement Clerk and Contract Manager.

Animal Control Officer Matthew McKale and Indian Health Service (I.H.S) will Be providing rabies vaccination services On August 21, 2025, from 2pm to 5pm.

We anticipate administering approximately 75 vaccination shots. In order to help us maintain a smooth and calm environment; we kindly ask that you keep your pets in your car until you are called up for service. This approach helps us manage the flow and keep stress levels low for your pets. This is a wonderful opportunity to ensure your pets are protected against rabies, a vital step for their health and health of our community.

Sec 89.42

Penalties Any person who violates any of the provisions of this Code shall be punished as provided in this Section. Each day this code is violated shall be considered a separate offence.

- A. The following is a schedule of mandatory fines:
- 1. For redemption of impounded animals: -first offense, five dollars (\$5.00); second offense, ten dollars (\$10.00); -third offense, twenty dollars (\$20.00); -fourth offense, confiscation of animal;
- 2. Unlicensed dogs, fifteen dollars (\$15.00) plus license fee;
- 3. Running at large, or animals disturbing the peace: -first offense, ten dollars (\$10.00); -second offense, twenty dollars (\$20.00); -third offense, thirty dollars (\$30.00); -fourth offense, citation for court action as pursuant to subsection (b) of this section;
- 4. No rabies vaccination, ten dollars (\$10.00) plus cost of vaccination;
- 5. too many dogs in one household: -first offense, twenty-five dollars (\$25.00) per excess dog; -second offense, as determined by the court.
- B. Any violation of this Code other than those listed in subsection

- (a) of this section shall be punished as determined by the Tribal Court. If any person is convicted of cruelty or mistreatment of an animal, that animal shall be removed from his custody and placed with the director.
- C. In addition to the mandatory fines for impounded animals pursuant to subsection
 - (a) of this section, an additional boarding fee will be charged by the animal control center.

Sec. 89.10 Rabies Vaccinations

- A. It is the duty of all persons owning or keeping a dog or cat over the age of three months to have such animals vaccinated against rabies. The rabies vaccination shall be given in an amount sufficient to provide immunity from rabies for three years and shall be administered by a licensed veterinarian or certified Indian Health Service environmental technical assistant. A certificate from a licensed veterinarian or certified Indian Health Service environmental technical assistant shall be evidence of vaccination. The director may require other animals to receive rabies vaccinations.
- B. The veterinarian or certified Indian Health Service environmental technical assistant administering anti-rabies vaccine to any animal shall issue to the owner or keeper of the animal a numbered vaccination certificate. The certificate shall contain the name and address of the owner or keeper of the animal, a description

of the animal vaccinated, the date of the vaccination and the expiration date of the period of immunity.

C. It is unlawful for the owner or keeper of any dog or cat to fail to exhibit its certificate of vaccination upon demand by the director or by the animal control officer.

VA award letter showing percentage of disability, NM Driver's License, ID, voter Registration card, and Widow/Widower copy of marriage and death certificates if applicable. NMDVS can help Veterans file for lost or misplaced DD 214s.
