## E-Cigarette & Vaping devices Disposal



### DEA National Take Back Day Vape Collection Guidance:

- DEA will collect vape pens or other e-cigarette devices from individual consumers **only** after the batteries are removed from the devices. It is important to stress that the DEA is not responsible for removing the batteries from the devices.
- If the battery cannot be removed, individual consumers can check with large electronic chain stores who may accept the vape pen or e-cigarette devices for proper disposal.
- Individual consumers may also contact their local Hazardous Materials Management Facility to determine if they accept these devices, and for additional guidance regarding proper disposal.

## Animal Control Officer Scholarships

Well-trained officers are an essential part of ensuring both community safety and animal welfare. That's why since 2004, APNM has offered training scholarships to New Mexico's animal control and law enforcement officers. Thanks to generous grant funding, just since 2018, this effort has already provided more than 300 scholarships to over 200 officers in 26 counties, six pueblos, and the Navajo Nation.

These scholarships give officers the tools they need to respond compassionately, enforce animal protection laws, and create safer communities for people and animals alike. As Officer Yuliana Salas shared, *"As an APNM scholarship recipient I have been able to learn crucial information for my job. It has been a good tool when interacting with animals as well as the public."*

For many officers, the training also deepens their passion for serving their communities. Officer Matthew McKale expressed, *"I love being able to wake up and work with animals every day. This opportunity allows me to do what I am passionate about in my community. I want to continue to spread animal love and safety awareness."*

The impact is especially meaningful in communities where resources are limited. Derek Valerio, Tribal Ranger/Animal Control Officer for Pueblo de San Ildefonso, shared how his scholarship has empowered him to better address animal welfare issues, provide informed emergency responses, and support spay/neuter and vaccination outreach. *"The support from APNM is not just an investment in me," he said, "but an investment in the future well-being of the Pueblo de San Ildefonso."*

We're proud to play a part in equipping officers with the knowledge and skills to serve their communities and safeguard animals. Together, we're helping create a safer and more humane future for people and animals across New Mexico.

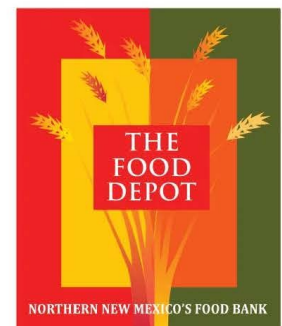
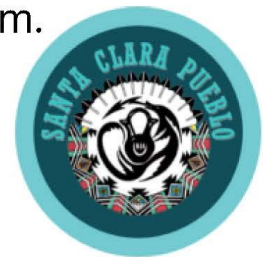

## Attention New Mexico Veterans who are Artists:

Dear Veteran:

As you may know, New Mexico Veterans Art (NMVA) hosts an annual, month-long November exhibition celebrating the national Veterans Day holiday. The 2025 exhibition—"The Way of Art"—will take place at the Step Up Gallery in Los Alamos, a beautiful space designed by New Mexico's own renowned architect Antoine Predock. The exhibition will run from October 30 - November 30, with a public reception on Saturday, November 1, from 2:00 - 4:00 PM.

The exhibition's theme—"The Way of Art"—references the the healing power of creative process. Veterans and others afflicted by trauma, often credit their art practice as helping heal traumatic memories.

In conjunction with the exhibition, I am seeking several volunteers who are veteran artists and would like to be interviewed for a video I hope to create. This effort is the continuation of work inspired after learning that not only creating art, but also viewing awe inspiring photos and videos can mitigate emotional distress.

In 2024, Dr. Jack Henningfield told me about research being done at Johns Hopkins University that indicates that people suffering from PTSD are helped by viewing landscape and nature photos and videos. Being a veteran photographer, that got me interested. Since then, I've worked with Jack on academic presentations and exhibits using my photos and videos.

I believe in the power of nature to heal our emotional wounds, and so I'm going to continue to pursue this for as long as I can. I've created a YouTube channel

and am continuing my collaboration with Jack. It also includes working with organizations like Santa Fe's Unhoused Art - Vital Spaces program and the New Mexico Veterans Art show.

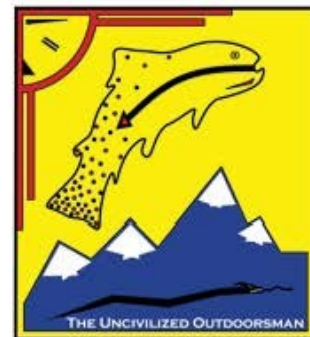
